## MICHIGAN MOTORCYCLE ACCIDENTS ARE ON THE RISE

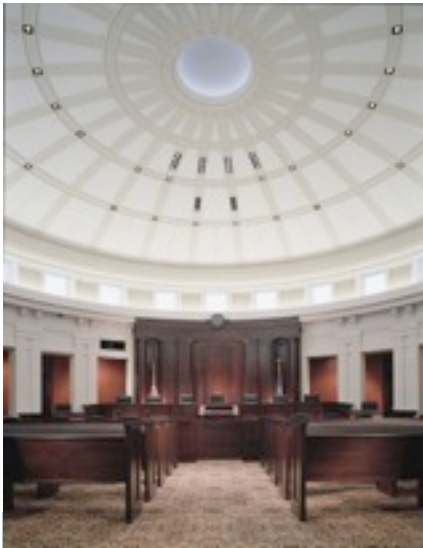
